Application are invited for the post of Director in the pay scale of Rs. 1,23,100-2,15,900/- Pay Matrix Level-13 on deputation basis in Department of Fisheries, Government of Uttarakhand, from Scientists/ Officers working in the ICAR Fisheries Institutes/State Agricultural Universities/State Universities/All department of Government Sector. The requisite qualifications are as under.

1. Scientists/Officers should be drawing minimum basic pay of Rs. 1,23,100-2,15,900 Pay Matrix Level-13 or one level lower Rs. 78,800-2,09,200 Pay Matrix Level-12. The pay of applicants drawing higher pay will be protected.
2. The applicant should have field oriented experience in fisheries and aquaculture with expertise in fish post harvest and designing, construction and management of hatcheries, fish farms etc.
3. The applicant should preferably have experience of formulation, preparation and execution of fisheries development plans/projects and negotiation with funding agencies at national and international levels.

The Scientists/Officers who fulfill the above qualifications/eligibilities may submit the applications in the prescribed performa at Annexure-1 through proper channel to the Secretary, Department of Fisheries, Government of Uttarakhand, Uttarakhand Secretrait, 04 Subash Road, Dehradun-248001 so, as to reach within maximum thirty days from the publication of the vacancy.
